NHS Test and Trace: COVID-19 testing for staff and students

As you will know schools have been asked to assist with testing for those without coronavirus symptoms using new, quicker COVID-19 tests known as 'lateral flow tests'.

Along with the other protective measures we are taking, these tests will help staff and students to remain in school safely. Up to one third of people who have coronavirus experience no symptoms. By testing we will help to stop the virus spread and help to keep our school open as safely as possible. The test is voluntary, but the government would encourage everyone to take it.

Subject to the availability of tests, we will be testing all staff and those students in school on a weekly basis from week commencing 11th January. Following this training week, all students currently attending school will be tested twice weekly. This will require consent from those students in school.

In addition, we would like to take this opportunity to also gain consent for all students to be tested should it be needed when the school reopens.

To give consent please access the 'COVID 19 Testing Consent' payment item on School Gateway and complete the online form for each child. If for any reason you are unable to provide consent via School Gateway please return the form below to testing@davinciacademy.co.uk.

Those taking the test will be supervised by staff who have completed the training provided to schools by the government. The 'lateral flow' tests are quick and easy using a swab of your nose and throat. For under 18s, staff can oversee the student carrying out the swab process for themselves.

Positive results which take around half an hour from testing will be shared directly with staff and pupils participating. A pupil will only be told if they test positive on a 'lateral flow' test, so if you do not hear you can assume it was negative.

The government have informed us: *"We know these tests work - in validation studies conducted by Oxford University and Public Health England, they were shown to be as accurate in identifying a case as a PCR test (99.68% specificity). The tests have lower sensitivity but they are better at picking up cases when a person has higher viral load, hence the need to test frequently."*

Testing will be offered free of charge.

NHS Test and Trace consent form for COVID-19 testing

This common consent form has been designed for use by parents and guardians of pupils under 16, pupils and students over 16 and staff. Underlined sections should be read as applicable and completed as follows:

- This form must be completed by the parent or legal guardian. Please complete one consent form for each child you wish to enrol.
- Staff will complete this form themselves.

Terms of consent

1. I have had the opportunity to consider the information provided by the school/college about the testing, ask questions and have had these answered satisfactorily, based on the information presented in the letter dated [08/01/2021] and the attached Privacy Notice.
2. I have discussed the testing with my child and my child is happy to participate. If on the day of testing they do not wish to take part, then they will not be made to do so and consent can be withdrawn at any time ahead of the test.
3. I consent to having / my child having a nose and throat swab for lateral flow tests. I / my child will self-swab if I / my child is able. I have discussed the testing with my child and they are happy to participate and self-swab.
4. I understand that there may be multiple tests required and this consent covers all tests for the below named person. If, on the day of testing I / they do not wish to take part, then I understand I / they will not be made to do so and that consent can be withdrawn at any time ahead of the test.
5. I consent that my / my child's sample(s) will be tested for the presence of COVID-19.
6. I understand that if my / my child's result(s) are negative on the lateral flow test I will not be contacted by the school/college except where I am / they are a close contact of a confirmed positive.
7. If the lateral flow test indicates the presence of COVID-19, I commit to ensuring that I / my child is removed from school premises as promptly as possible, bearing in mind I / they may have some anxiety following a positive test result.
8. If the lateral flow test indicates the presence of COVID-19, I will ensure that I / my child will undertake a confirmatory PCR testing, this will be via either an NHS testing center or a kit provided by school. I / they will follow the instructions on the PCR Kit to return the test the same day to an NHS Test & Trace laboratory.
9. I consent that I / they will need to self-isolate following a positive lateral flow test result, until the results of the confirmatory PCR have been received.
10. I agree that if my / my child's test results are confirmed to be positive from this PCR test, I will report this to the school / college and I understand that I / my child will be required to self-isolate following public health advice.
11. I consent that if a close contact of my child tests positive, but I / my child has tested negative, I / they will continue to attend school / college but will be tested every day at school / college for 7 school days.

What if a pupil tests positive?

Participating staff and pupils who test positive will be informed about their results individually. Parents and legal guardians will also be notified. Guidance on safe travel and additional precautions will be provided along with test results.

Pupils will need to take a further 'PCR test' (similar to those done in local and regional testing sites) on the same day (or as soon as possible). School will be able to provide these PCR test kits to perform at home or you can go to www.gov.uk/get-coronavirus-test or call 119 to book a follow-up test. If ordering a PCR test yourselves, they should choose to visit a drive-through test site if possible, as it is faster than requesting a home test.

During this time while they wait for the PCR result (via text / email) they will need to self-isolate.

If the PCR test returns a positive result you will have to self-isolate and follow the guidance from NHS Test and Trace.

What happens if the test is negative?

They will be able to stay in school and resume their activities as normal. A pupil will only be told if they test positive on a 'lateral flow' test, so if you do not hear you can assume it was negative. A small number of pupils may need to repeat the test if the first test was invalid or void for some reason.

What if a close contact at school tests positive?

A close contact of someone in school who has tested positive for COVID-19 will be able to return to school if they agree to be tested once a day for 7 school days and the test is negative. If they do not want to take the test, they will need to self-isolate as per the national guidelines. This does not apply to household members or close contacts outside of school who will still need to self-isolate. Further details will be provided at the time, but if you would prefer to self-isolate instead of doing daily testing, you can.

What if my child develops symptoms?

This testing programme at school is for people with no symptoms. If your child develops symptoms at any time (such as a high temperature; a new, continuous cough; or a loss or change to their sense of smell or taste) they must immediately self-isolate, and book a test by calling 119 (England, Wales and Northern Ireland) or 0300 303 2713 (Scotland) or visiting <https://www.gov.uk/get-coronavirus-test>.
